4. Report of Treasurer	Ted Sherman, Treasurer					

Ted Sherman provided a report. Initial employee retention credit funds have applied. Cash is being watched very carefully. Cathedral Staff is working diligently on reducing costs. Bryce Estate Lionheart Scholarship payments are immediately pending. Urgency in fundraising is needed due to cashflow shortage. All In One Accounting can provide an in-person deep-dive regarding finances and recommendations with the Council in the Fall. Restricted funds for specific programs, which St. Marks is liable to pay, were discussed. Restricted funds amount to approx. \$100,000. The cathedral does not currently have the cashflow to cover current restricted funds and operational costs. Heavy snowfall removal

costs and inflation have been primary causes. It was noted that cuts were made in the current budget when it was crafted last winter, and efforts are ongoing to reduce spending. The upcoming Dean transition will provide some relief in costs. No action was taken at this meeting, but this is an ongoing discussion as cashflow has reached emergency levels.

It is estimated that pledges need to be increased by 12% (roughly \$300,000) over the next several years. The bishop's potential role in recruiting major donors, especially in light of the Dean transition, was discussed.
